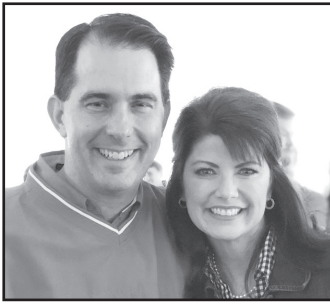

Did You Know All 5 of These Baby Body Parts Bills were Killed by the Republican Party?

This interesting timeline shows that the GOP has killed All Baby Body Parts Bills in committee to date. *What a Scandal!* Expect more of the same going forward if Vos remains at the helm of the State Assembly.

- 2011** Assembly Bill 214/Senate Bill 172 was killed by GOP Representative Garey Bies and Senator Rich Zipperer (he was later Walker’s Chief of Staff).
- 2013** Assembly Bill 224 was killed by GOP **Representative Joel Kleefisch**.
- 2015** Assembly Bill 305/Senate Bill 260 was killed by GOP Representative Jim Steineke and Senator Scott Fitzgerald.
- 2017** 2017 Assembly Bill 549/Senate Bill 423 was killed by GOP Representatives John Spiros and Jim Steineke and Senator Van Wanggaard. (As she was preparing to run for Congress, Senator Vukmir killed the bill by having it routed to pro-abortion Senator Wanggaard’s committee.)
- 2019** Assembly Bill 590/Senate Bill 524 was killed by GOP Representative Rob Swearingen and Senator Van Wanggaard.
