TEACHING ABOLITIONISM AND INTERPOSITION IN KENTUCKY

From July 22nd to July 28th, hundreds of people gathered in Kentucky at the invitation of Operation Save America to take action on behalf of the preborn. Pastor Matt Trehwella was invited to speak on the doctrine of the lesser magistrates and spoke to a crowd of several hundred on Monday evening, July 24th. He called upon the attendees to establish a 'mission to the magistrates' in their state and county.

For too long Christian men have avoided the public realm of civil government. The result has been that wicked men have now filled the void and have put their worldview into place through the force of law and public policy. Evil is now enshrined in our nation - evil is now declared to be good, and good is now declared to be evil. The Church in America needs to repent of this negligence.

Instructing the magistrates (and the people) from the Word of God regarding their duty is needed in our day. This can be done through conversation and meetings. And here you see that it can also be done through published writings in a local paper. This full page newspaper ad instructs the magistrates and the people about the duty of magistrates to interpose against evil and lawless acts by the federal judiciary. This ran in the city newspaper in Frankfort, Kentucky - Kentucky's capitol.

When the Christian Apologists of old wrote their works from 150 - 350 AD, they addressed their writings first to the magistrates of their day - then to the people. The Christians of our day need to do the same and instruct the magistrates (and the people) in Christian thought. God's Word speaks to all matters of life - including matters of civil government.

About 25 people traveled from Wisconsin to participate in Kentucky.

LESSER MAGISTRATES ARE SENTINELS

In 1859, the Wisconsin Legislature defied the U. S. Supreme Court and the entire federal government by declaring the federal Fugitive Slave Act to be “*null, void, and without authority*” in the state of Wisconsin. This act of interposition was needed and necessary.

The Wisconsin Supreme Court also defied the U. S. Supreme Court and the entire federal government. The federal government was charging Sherman Booth under the Fugitive Slave Act for helping a runaway slave in federal custody escape from jail. Justice Abram Smith stated in the *Booth* case: “*The duty of the states to watch closely and resist firmly every encroachment of the federal government becomes every day more and more imperative, and the official oath of the functionaries of the states becomes more and more significant.*”

After making plain the duty of the states, Justice Smith then spoke from a more personal level. He wrote in *Booth*:

But believing as I do, that every state officer who is required to take an oath to support the Constitution of the United States as well as of his own state, was designedly placed by the federal constitution itself as a sentinel to guard the outposts as well as the citadel of the great principles and rights which it was intended to declare, secure and perpetuate, I cannot shrink from the discharge of the duty now devolved upon me.

Smith understood his duty as a sentinel - as a state magistrate. His duty was interposition. Defiance of SCOTUS. A sentinel is a watchman who guards against the approach of danger. Today we have a lawless federal judiciary once again. SCOTUS dispenses injustice and immorality. The preborn are being butchered and God’s created order for marriage is impugned. Where are the sentinels of our day?

They appear to be busy covering and singing the common song - “The Supreme Court has ruled - all we can do is obey.” Justice Smith and the legislators of 1859 defied federal law. When it comes to the slaughter of the preborn and perverting of marriage there is no federal law - just a mere court opinion. Yet they cower and quibble.

Justice Smith went on to write:

I know well its consequences, and appreciate fully the criticism to which I may be subjected. But *I believe most sincerely and solemnly that the last hope of free, representative and responsible government rests upon the state sovereignties and fidelity of state officers to their double allegiance, to the state and federal government; and so believing, I cannot hesitate in performing a clear, an indispensable duty.*

Interposition *is* an indispensable duty. If the state and county magistrates bow down to the federal tyrant, the federal tyrant has the convenience to build the next plank of his tyranny. The federal judiciary has been doing that for decades now.

The interposition of the state and county magistrates is needed and necessary.

IT HAS BEEN OVER 4 DECADES OF "LEGAL" MURDER.

Since 1973, over 60 million living human beings who were created in the image of God have been brutally and mercilessly murdered by their parents, with the assistance of medical professionals.

Very few in our nation have treated this injustice as though it is murder, including the Pro-Life Movement.

When Roe v. Wade was passed and abortion was made "legal," the governing officials and Christians of every state had the duty to defy SCOTUS and disallow the murder of the preborn. **They did not.**

With neither the Church nor the governing authorities doing their duty, Pro-Life fundraising organizations arose in their place.

WHAT HAS THE PRO-LIFE MOVEMENT WON?

Wisconsin Abortion Regulations (How We Regulate Murder):

- Ban abortion after 20 weeks
 - Repeal penalties for women who commit abortions
 - Require mothers to see ultrasounds before murdering their children
 - Require mothers to wait 24 hours before murdering their children
- (And numerous more)

Yet Wisconsin continues to murder 6,000 babies every year.

Over 300 Pro-Life laws have been passed in the U.S. in the last 6 years.

Yet the United States continues to murder 1 Million babies every year.

IF THE PRO-LIFE MOVEMENT IS WINNING, WHAT IS THE GOAL?

If dictating how and when babies are murdered is "winning," your goal is wrong.

The regulations being passed by the Pro-Life Movement are pro-choice. They all affirm that women have the right to murder their preborn children. The Pro-Life Movement helps to keep abortion legal by putting forward a never ending stream of incremental Pro-Life victories that legitimize both the murder of the preborn and the idea that the Supreme Court can create and impose tyrannical laws.

These regulations help ingrain the pro-choice mindset into the culture by treating abortion as a valid choice that should be safe, legal, and rare.

WHAT MUST BE DONE?

- Stop acting as if abortion is not murder in your rhetoric and laws. **We must instead call for the immediate and total abolition of abortion.**
- Stop claiming that regulations are "the best that we can get." Complete abolition will not be accomplished over night, but it will never be accomplished if we never demand it, favoring the regulation of how murder is committed and who is allowed to commit it.
- Stop hiding behind the excuse of, "The Supreme Court ruled, so we must obey! We have to work within the framework of Roe!" **SCOTUS is a tyrant that must be defied.** When they make unjust, unconstitutional rulings, all other branches of government must defy those rulings and uphold justice.
- We all must repent of our part in the dehumanization of our preborn neighbors, and thereby follow Christ as King and learn to think and act righteously.
