One of our former missionaries, Dale Pultz, who was arrested over 100 times and spent nearly two years in jail for interposing on behalf of the preborn at the doors of the deathcamps here in Milwaukee, has gone to be with our Lord. He was 57 years old. He had pneumonia.

I first met Dale at the corner of 60th & Capitol Dr. on Milwaukee's north side. The year was 1990 and the Missionaries to the Preborn had targeted our first deathcamp, named Bread & Roses. It was the highest-volume killing-center in all of Wisconsin, but we believed the Lord wanted us to go there. We interposed at the doors on behalf of the helpless preborn every day they were open - three days a week.

Dale had to switch buses on that corner - so he would watch our interposition and our arrests. Unlike most passers-by, he was not indifferent. He asked questions. We explained the slaughter. He was completely opposed to their unjust brutal deaths. But Dale was an atheist. We would talk and debate with him about Jesus out on that corner. He was glad we were doing what we were doing, but his disdain for God was great.

After about a month, I was sitting in jail already arrested. (We would get arrested at different points in the morning as two or three or even just one of us would interpose as each woman approached. There were I7 of us in all. We were committed to do this until B & R was closed down or we were dead), when in walks Dale with a couple other of the missionaries.

I asked them "What is he doing here? What happened?" They explained that when a woman was coming to murder her son or daughter, Dale ran to the door and placed himself in front of it to protect the child and talk to the mother. The police tried to talk Dale out of going through with his action - but Dale stood firm for the little one.

Dale began getting arrested with us two of the three days each week. We ended up talking to Dale for hours in jail over the next two months sitting in jail together. We debated all his arguments that made him an atheist. Finally - thanks be to the Lord! - Dale repented in brokenness and gave his life to Christ! (I weep thinking of it even now).

Jesus makes blind men see.

Dale was odd in many ways. And boy could he eat. But he was a new man. He wasn't the best at talking with others but could argue well - now for our Lord. And I saw him do this with other inmates while I spent weeks in jail with him.

Dale never quit ministering for the preborn. He came to our monthly photo displays for the preborn at busy intersections and other efforts all the way till the end of his life here on earth.

## The Failed Pro-Life Strategy of Waiting for SCOTUS to Undo Roe

Supreme Court once again affirms Roe in Louisiana Case

The pro-life/pro-family organizations who want us to continue to run to the tyrant to undo their tyranny have been proven wrong again. Have been for nearly 50 years now.

This is the 38th time the Supreme Court has affirmed Roe since 1973.

But the pro-life/pro-family groups will do it all again. Keeps their coffers full of money and provides cover for all the GOP frauds who pay mere lip-service to the preborn. That way they give the appearance that they are doing something - while they're really doing nothing.

They have conned those opposed to the murder of the preborn that we must obey the federal courts. That we must stand by while they murder helpless preborn human beings made in the image of God until the Supreme Court (SCOTUS) reverses Roe.

And that is the lie they tell their supporters.

David Horowitz stated regarding this year's SCOTUS rulings, "Taken in totality, the conservative legal movement, which has promoted the idea of "appointing better judges" rather than fighting the entire concept of judicial supremacism, has failed miserably. This was its Waterloo."

Horowitz is correct - judicial supremacy is an evil and it must end. The three fictions judicial supremacy asserts is that I. Supreme Court opinions are the law of the land, 2. That the Supreme Court is the final arbiter of all constitutional questions, and 3. That all other branches of government must obey the Supreme Court. And this is all a lie.

America's founders never said such a thing. America's founders never would say such a thing. As legal historian Alpheus Thomas Mason wrote not too long ago: "Implicit in the system of government the Framers designed is the basic premise that unchecked power in any hands whatsoever is intolerable."

Any human institution that is not accountable to other human institutions will corrupt itself. History has proven this.

America's government officials have granted limitless, unaccountable authority to the Supreme Court. They have aided and abetted the Court's evil by their unlawful obedience to their immoral and unjust decrees. The federal judiciary and the Supreme Court have been dragging this nation into hell for decades now. Because the whole nation thinks they are beholden to the Supreme Court, evil grows.

America's founders, on the other hand, established this nation as a true federalism. In a true federalism there are multiple levels of government and multiple branches on each level. They did this because they held to a Christian view of man – that men are wicked and in need of a Savior, namely, Jesus Christ.

They did not want power to rest in one man or a small group of men.

The founders established a federalism so the various branches would check the others if they acted wrongly.

The intent, therefore, of a true federalism is: if any one branch begins to play the tyrant, it is the duty of the other branches to interpose and resist that branch – and stop the evil - even if that branch is the federal judiciary and the Supreme Court itself.

All public authorities (magistrates) possess lawful authority. If federal authorities do wrong, it is the duty of state, county, and local authorities to step in and stop the evil. If state authorities do wrong, it is the duty of county and local officials – and perhaps federal officials - to step in and stop the evil.

State, county, and local magistrates take an *oath* to uphold both their State Constitution and the U.S. Constitution. They do not take an oath of subservience to the federal government, nor do they take an oath to blindly implement immoral and unjust court opinions issued by the Supreme Court and the federal judiciary. Rather, they take an oath to uphold the Constitutions. If therefore, another authority makes law, policy, or court opinion repugnant to the state or federal constitutions – they should not obey them. Their duty is to interpose against them.

Those who oppose the brutal slaughter of the preborn must demand that the leaders stop the nonsense of going with hat in hand to the tyrant – bringing yet another case to try and undo Roe. Interposition is needed and should be demanded. They must also quit giving money to such failed leadership.

Understand, the pro-life movement does not treat abortion as murder. The pro-life movement treats the murder of these helpless ones as healthcare. The Louisiana case decided on June 29th had nothing to do with ending the murder of the preborn. Rather, it was about making sure an abortionist had admitting privileges at a nearby hospital. The pro-life movement brought a near identical case from Texas and were defeated by the Supreme Court just four years ago.

Interposition, on the other hand, stops the murder. The states must ignore and defy the Supreme Court, and uphold their state laws against this murder. We must demand it of them – and rally behind them when they do.
