23 Christians Facing up to 32 Years in Federal Prison

Christian men have long abandoned the civil realm. And so wicked men have filled the void. And wicked men have made their worldview law, policy, and court opinion. So evil has now been declared to be good and good has been declared to be evil by our government.

Oh, and have you noticed that you now live in an insane asylum?

And the consequences of decades of this indifference and failure to engage in the civil realm is becoming more evident as the suffering of Christians (and others) grows.

Very few Christians and Americans are aware that our federal government has indicted *23 people* – most of whom are Christians – for prayerfully and peacefully interposing at the doors of deathcamps in order to protect the preborn from a brutal and unjust death.

They face up to 32 years in federal prison each.

Charges have been brought in Washington D.C., Tennessee, Michigan, and Florida. Those being charged range from a 21 year-old female missionary to an 88 year-old Christian woman who was once in a deathcamp in Europe as a child near the end of World War II.

The charges include the FACE Act (Freedom of Access to Clinic Entrances Act), conspiracy, and the Human Rights Enforcement Act of 2009.

Understand – these people took peaceful action to protect preborn human beings from being *murdered by abortion* and they are being charged with violating the civil and human rights of those who want to murder their own sons and daughters under the Human Rights Enforcement Act.

This is the insane asylum America has become.

The Human Rights Enforcement Act criminalizes genocide, torture, war crimes, the use of children as soldiers – AND criminalizes – under number 5 – those who violate “*the rights of people to have safe access to reproductive healthcare clinics.*”

The American federal government is a wicked regime.

Each of these Christians are facing 10 years on the Human Rights Enforcement Act alone.

Nine of the individuals have already been found guilty in Washington, DC this past September.

The female federal judge is a tyrant who conducted an unfair trial in her kangaroo court. She accuses them of being violent when they were not. She has held them in federal custody since then – and they will not be sentenced until May.

One of those individuals – Jonathan Darnell – is a Christian brother who has ministered on behalf of the preborn outside DC deathcamps for years, and has taught the doctrine of the lesser magistrates throughout the area via DefyTyrants.com.

Trial is set for January 16th in Tennessee and set for April 11th in Michigan.
