Dear Friends of the Preborn,

At the beginning of 2025, the situation with the preborn and abortion here in Wisconsin are as follows:

Wisconsin Statute 940.04 which outlaws all abortion in Wisconsin is still on the books; also - the Wisconsin Supreme Court still has not issued their opinion regarding the case to dismantle 940.04; but unfortunately, all the magistrates in our state continue to refuse to do their duty and uphold the statute.

Hence, all the deathcamps remain open in Wisconsin. Also, all of the chemical abortion devices are back on the shelves at Walmart, Walgreens, CVS, Target, and so many others. People can also order these murder devices online in Wisconsin and every other state in America.

The magistrates have behaved so badly in this situation. It was a year ago at this time that I and others testified in Madison against a bill brought by Robin Vos (Republican Speaker of the Assembly) and the Republicans that would have allowed the murder of the preborn up to 14 weeks (95% of abortions have taken place by that time).

The government officials have joined hands with Planned Parenthood to flout the law, rather than protect the preborn.

After being in this fight for the preborn since in 1987 – I sadly have to declare – the pro-life movement has settled back into its status quo where they claim they are doing something – but in reality, they are not doing much of anything. And – in the midst of it all – they fill their coffers full of money while they dispense false hope.

The pro-life movement is once again at a low ebb. I would encourage you to join with those who speak of abolition and abolitionism. But even there you must be discerning – as some pro-lifers and pro-life groups like to use the rhetoric of abolitionism, but still promote those who want to continue with incrementalism and regulationism.

It is sick to the heart to watch the political pro-life groups get rich off the bloody backs of the murdered preborn while they know their efforts are going nowhere. As I noted in our last newsletter – 2024 was a bloodbath for the preborn in America.

Though we continue to engage the magistrates, Missionaries to the Preborn also will continue to minister on the streets at Milwaukee's deathcamps, and at universities and busy intersections in the Midwest and across the nation. We will also continue to instruct government officials in the doctrine of the lesser magistrates. Thank you so much for your support.
