Dear Friends of the Preborn,

September 17th we put out a red alert that **Planned Parenthood** intended to *reopen their deathcamps* in Milwaukee and Madison and begin to murder the preborn after a 15-month hiatus from the slaughter.

We addressed the “legal” matters in our press release that we sent out [see the back of this page to read the press release]. We did many interviews with the media including NBC national news. Many of you thanked us for our response in the news.

On Monday, September 18th, they began the murder.

Here is info about some of what happened on Monday, September 18th when we gathered outside Planned Parenthood’s deathcamp in Milwaukee.

About 60 came out to the Planned Parenthood deathcamp in Milwaukee on Monday to speak up for these little ones.

We called upon the police at the scene to arrest the abortionist and uphold Wisconsin 940.04 - but the police said they would not arrest the abortionist. In fact, the police told those gathered to speak up for the preborn that they were there to arrest them – *not the abortionist* - if they caused trouble.

One officer later confided that all the officers sent to the deathcamp were warned that if they tried to uphold Wisconsin statute 940.04 and arrest the abortionist - *they would lose their job*.

When my son Matthew called 911 to report the murder and the flouting of Wisconsin law - he was told by the operator that they would not be responding to the situation - and hung up in his face.

Planned Parenthood is murdering the preborn again in Wisconsin.

This is evil and sadly, there is not a single government official willing to uphold Wisconsin law and protect these little ones. God's judgment is just on Wisconsin.

Thankfully, *there was one baby spared from death* that we know of because of the Christians gathered out there. May Christ be praised!

But our hearts are grieved over this murder and the government officials allowing this slaughter. On the back is the sermon I preached on Sunday, September 24th wherein I addressed the situation in Wisconsin and our nation.

PRESS RELEASE

Missionaries to the Preborn has gathered with others outside Planned Parenthood's deathcamp located at 435 S. Water St. in Milwaukee, Wisconsin this morning September 18th, to stand with the preborn and call upon Wisconsin government officials to **uphold Wisconsin law** and arrest the abortionist at Planned Parenthood.

THE 1849 LAW – WISCONSIN STATUTE 940.04- IS THE LAW IN WISCONSIN. IF PLANNED PARENTHOOD MURDERS A PREBORN CHILD, THEY HAVE VIOLATED WISCONSIN LAW - AND THE ABORTIONIST SHOULD IMMEDIATELY BE ARRESTED BY THE MILWAUKEE SHERIFF OR MILWAUKEE POLICE. PLANNED PARENTHOOD OFFICIALS SHOULD BE ARRESTED FOR BEING A PARTY TO THE MURDER.

Diane Schlipper is a measly county judge. She possesses no authority to trample Wisconsin law.

If the 1849 law against abortion holds no weight – *then why has Wisconsin Attorney General Josh Kaul filed a suit to attack it and is trying to get it overturned in the courts?* Planned Parenthood officials are lying when they say Schlipper has ruled that 940.04 holds no weight and is not law. **She has only ruled that Josh Kaul's lawsuit can move forward.**

Both Milwaukee Sheriff Denita Ball and Police Chief Jeffrey Norman have a sworn duty to uphold Wisconsin law, as do all their officers.

Their departments have a duty to arrest the abortionist and the Planned Parenthood officials that are party to the murder. Wisconsin's anti-abortion statute 940.04 is part of Wisconsin's homicide statutes. An abortionist can be imprisoned for 6 years (Class H felony) for murdering a preborn child. 940.04 states that "unborn child means a human being from the time conception."

Wisconsin has innocent blood on its hands for the slaughter of the preborn in our state from 1973 to 2022. More murder of these little ones will add to the just judgment of God upon the heads of Wisconsinites.
