



THE PREBORN IN WISCONSIN IN 2025

**Americans no longer celebrate liberty,
they celebrate license.**

And that was the case on July 2nd when the Wisconsin Supreme Court declared that Wisconsin's 1849 anti-abortion statute 940.04 was no longer valid. Wisconsinites celebrated this as freedom.

Our Attorney General here in Wisconsin, Josh Kaul, stated regarding the ruling:

"This marks a major victory for reproductive freedom... At a time when rights are endangered, this ruling is a powerful reminder of the importance of advocating for our freedoms."

Our governor Tony Evers commended our state Supreme Court and called the murder of one's sons and daughters a "basic freedom."

The Wisconsin Supreme Court stated in their decision and ruling that the newer state laws regarding abortion made over the last 50 years – all made by pro-lifers btw – and all which legitimized the murder of the preborn through law - superseded the 1849 law 940.04.

The Court wrote:

"We conclude that comprehensive legislation enacted over the last 50 years regulating in detail the who, what, where, when, and how of abortion so thoroughly covers the entire subject of abortion that it was meant as a substitute for the 19th century near-total ban on abortion. Accordingly, we hold that the legislature impliedly repealed [the 1849 ban] to abortion, and that [that law] therefore does not ban abortion in the State of Wisconsin.;

Of course, they were not meant as "a substitute", they were meant to regulate abortion because of Roe.

These bills and laws were a grave mistake.

Understand what we have here. The court took all the laws introduced by the pro-life groups to regulate abortion during Roe – and passed by pro-life GOP politicians - and used those laws to justify their ruling regarding the invalidation of 940.04 which actually criminalized the murder of the preborn.

I warned of this all the way back to the early 90's. I even debated Wisconsin Right to Life in writing, and on VCY. They said the laws they were writing and introducing, and passing would never supersede 940.04. I said they could and likely would be used to supersede 940.04. And here we are. I was dismissed as a non-lawyer who knew nothing – and yet, here we are.

Now the pro-family groups and pro-family politicians have been doing the same things with sodomy since the Obergefell opinion in 2015, they are legalizing the filth of Sodom to accommodate the Supreme Court, just like they did with Roe. They are legitimizing homosex through state statutory law. And this is a grave mistake.

The duty of the pro-life groups and pro-life politicians was interposition against abortion, not accommodation of abortion via regulation. Just like the duty of pro-family groups and politicians is interposition *against* homosex, not accommodation.

What do I mean by interposition?

Our GOP majority legislature and our GOP governors should have simply told the Supreme Court of the United States (SCOTUS).

NO! No one will be murdered here.

But instead of interposition, the GOP used the preborn as political footballs for their own ends.

Abortion should matter to Wisconsinites because abortion involves the shedding of innocent blood, and innocent blood beckons the judgment of God on a nation.

But the churchmen want to be silent.

Churchmen do not get involved because they view abortion as a “political” issue. And they have been taught by American Christianity NOT to be involved in political issues.

As Christ’s ambassadors, we have a duty to declare God’s law to the nations and His law declares “You shall not murder.”

So what is needed?

First, repentance is needed. We must call ourselves to repentance- we must call Christians to repentance.

We must call Wisconsinites to repentance.

Repentance for our indifference, repentance for our silence, repentance for our compromise with evil.

Second, the churchmen need to thunder against this bloodshed. They must pound against this evil. They must declare the truth of God’s Word regarding this matter – and instruct their people to engage and confront this evil.

Third, all compromise with this bloodshed must end. Abortion must be completely outlawed.

Both the abortionist and the mother, as well as all those who act in complicity with the murder, criminalized.

Fourth, all “pro-life” groups and “pro-life” politicians must be taken to task when they do less than complete criminalization.

Fifth, and final, we must go to the streets, to the highways and byways, and declare the truth of this bloodshed – *expose the slaughter* – the evil, with photographs and words.

The just judgment of God looms over this nation due to the shedding of innocent blood.

Be assured – if we will not act, the Lord will pour out His just judgment upon this nation. Innocent blood, according to the Word of God, demands His just judgment.

May we be faithful to Christ.
